Sexual Assault in the Military: Legal Problems & Remedies (1 Hour MCLE Credit)

Roughly one quarter of female service-members and one in ten male service members experience sexual assault. However, their options for legal redress are more limited than civilians'. This panel will discuss these barriers to justice, including the Feres doctrine's bar on civil lawsuits against the military. It will also detail military processes for investigating sexual assault and describe the support services available to Military Sexual Trauma survivors.

Discharge Upgrades: How to Restore Veteran Status and Benefits (1 Hour MCLE Credit)

Over 500,000 former service-members have other-than-honorable discharges, known as “bad paper.” In fact, the military is now issuing bad paper discharges at a higher rate than ever before. Service-members are often discharged due to behaviors stemming from traumatic experiences, such as assault or combat. Yet, under federal law, they do not qualify as “veterans” and are ineligible for VA benefits. This panel will describe the military’s discharge processes, including Court Martial proceedings, and how to petition the DOD for restoration of veteran status.

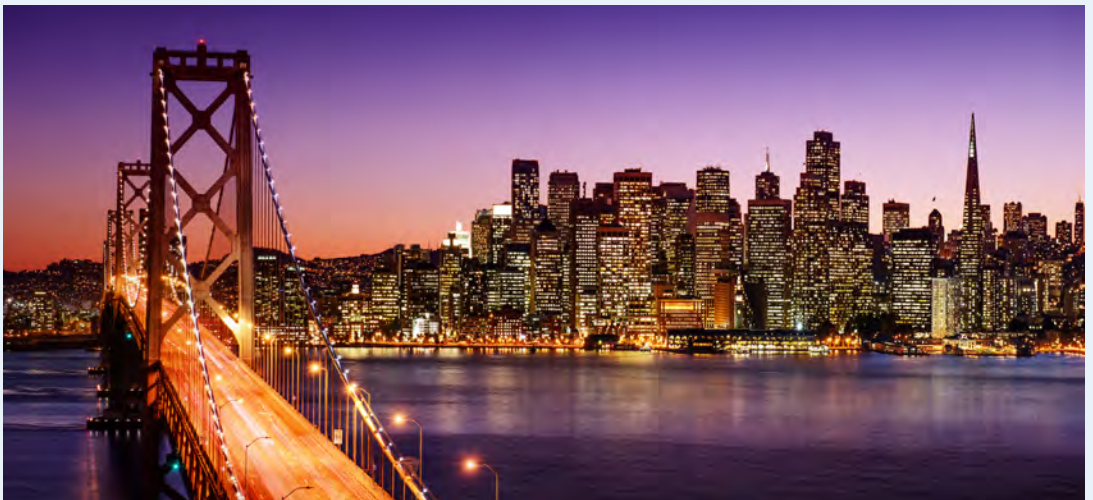
