Symposium Description

While COVID-19 is a public health crisis, society's response to the pandemic raises compelling legal and constitutional issues. How does the federal government, for example, have the power to mandate vaccination or masks in the workplace? Do vaccine and masking requirements violate personal liberty?

On February 10, 2022, from 9:00 a.m. to 12:30 p.m., the Business Law Section is hosting a series of webinars focused on legal issues arising from COVID-19 entitled Pandemics and the Law.

Our keynote speaker, Professor Matthew Coles, will examine the COVID-19 pandemic within the larger context of the rights and liberties granted by the Constitution.

Our second panel, consisting of Kate Bowles and Craig, will discuss potential effects of COVID-19 on the healthcare system including legislative efforts to address future public health emergencies and the shift to online care.

Finally, Michael Simkin will examine the various laws enacted by the State of California and several cities and counties that suspended the eviction process for residential and commercial tenants.

The constitution and the pandemic. The authority to respond to a public health crisis such as COVID-19 arises from the U.S. Constitution, state constitutions, regulations, and case law. These laws, however, often conflict. The plenary will address: 1) does the federal government have the power to mandate vaccination or masks in the workplace; 2) do vaccine and masking requirements violate personal liberty; 3) does the constitution require religious exceptions to vaccine requirements; and 4) can states prevent employers or businesses from requiring masks or vaccines?

Matthew A. Coles teaches Constitutional Law, Civil Procedure, Sexuality, Gender and Law, and Voting Rights at UC Hastings. He was Deputy National Legal Director of the American Civil Liberties Union from 2010 until 2016. Prior to that he ran the ACLU's National LGBT Project from 1995 to 2010. Before that he was an ACLU Staff Attorney in Northern California from 1987. After graduating Hastings in 1977, he opened his own law office in San Francisco, which eventually became Coles and Nakatani. He has been involved in the

LGBT civil rights movement since law school, when, as a legal advisor to Supervisor Harvey Milk, he drafted what became San Francisco's sexual orientation nondiscrimination law.
